## School Ready

- FY23 School Ready funding is \$2,980,513
- Carry Forward funds total \$293,103.61
- FY23 Total School Ready funds \$3,273,616.61
- Interest accrued through October 2022 totals \$3,380.37

- Expended School Ready funds end of October 2022 total \$391,868.83
- At the end of October 2022 11% of School Ready had been expended. End of October 2021 15% of funds had been expended.

## Early Childhood

- FY22 Early Childhood funding is \$970,864
- Carry Forward funds total \$96,154.88
- FY23 Total Early Childhood funds \$1,067,018.88
- Interest accrued through October 2022 totals \$1,410.43
- Expended Early Childhood funds at end of October 2022 total \$190,152.58
- At end of October 2022 18% of Early Childhood had been expended. End of October 2021 19% of funds had been expended.
